### Minimum Qualifications and Working Experience

Applicants should be Ugandan Citizens in possession of an Ordinary Level Certificate, Advanced Level Certificate, a Bachelor of Laws (LLB) Degree from a recognized University/Institution, and a Post Graduate Diploma in Legal Practice from the Law Development Centre or a recognized Institution.

Possession of Advanced/ Post-Graduate qualification(s) and demonstrable digital skills will be an added advantage.

Applicants must have served as a Justice of the Supreme Court of Uganda or of a Court having similar jurisdiction or has practiced as an Advocate for a period of not less than twenty years before a Court having unlimited jurisdiction in civil and criminal matters.

Any period during which a person has practiced as a public officer holding an office for which qualification as an Advocate is required, shall be included in the calculation of the required period of practice required under clause (1) of Article 143 even though that person does not have a practicing certificate.

The incumbent will be responsible for the following duties:

- Be the Head of the Judiciary and responsible for the administration and supervision of all Courts in Uganda.
- Preside over all the sittings of the Supreme Court in the exercise of its adjudicatory functions.
- (iii) Issue orders and directions to the Courts necessary for the proper and efficient administration of justice.
